Do you lose it when you fight? Learn from experts in listening, in brain processing, and in problem-solving how to keep your cool under fire.

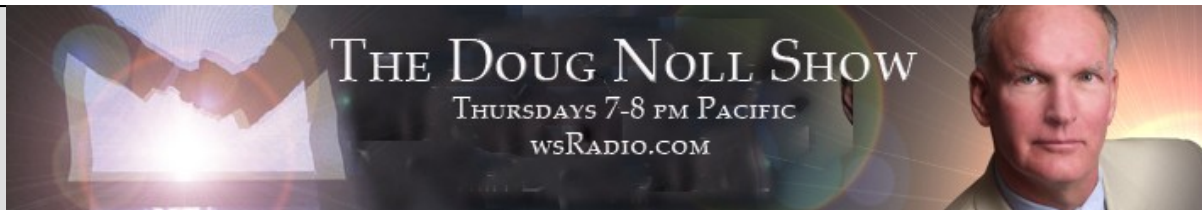
Tired of being a victim? Learn how to empower yourself with effective and powerful tools.

Questions

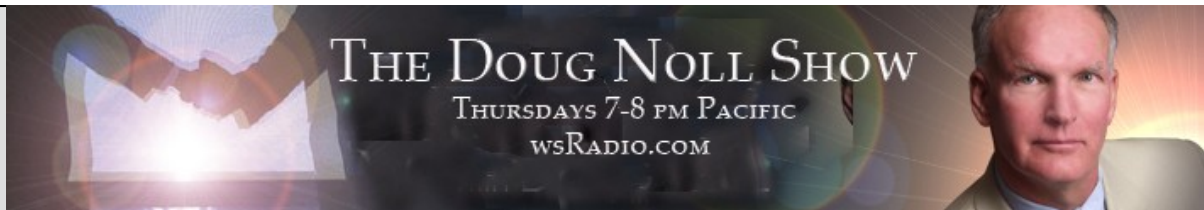

We can prepare a standard press release about the show customized with your show description. We will send this out if we know the names of your local newspapers.

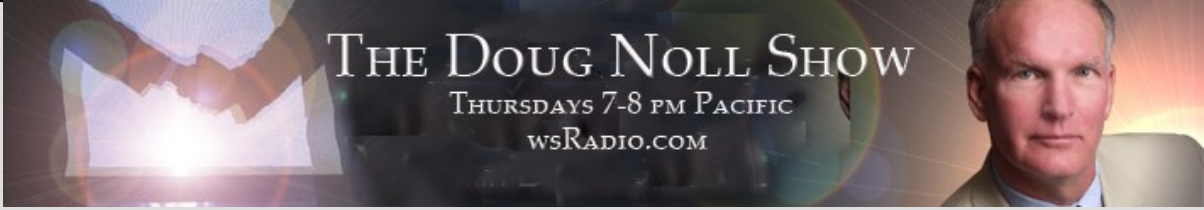
Web Listing and Links
